LOCATION OVERVIEW

Located in the heart of Williamsport's Newberry submarket, 835 1st St sits directly across Maynard Street from the main entrance to Pennsylvania College of Technology (Penn College), a 4,000+ student campus that drives significant daytime population and pedestrian traffic. The site is part of the emerging Maynard Commons retail hub, flanked by the new Chick-fil-A to the east and a recently constructed Wawa convenience store and gas station to the west, with excellent visibility and access from both Maynard Street and 1st Street. Less than five minutes from US-15 and two minutes from I-180, the location combines strong suburban residential support from the surrounding Newberry neighborhoods with institutional and commuter draw, all within a revitalized corridor benefiting from recent infrastructure upgrades and growing commercial momentum.

TRADE AREA OVERVIEW

The primary trade area within a 3-mile radius encompasses approximately 25,000 residents plus a substantial daytime population boosted by Penn College's 4,000+ students and 1,000+ staff, while the 5-mile ring expands capture to roughly 60,000 people across Lycoming County's core. With a youthful median age of 32, median household income around \$52,000-\$58,000, and a mix of student, blue-collar, and professional households, the area supports strong quick-service and convenience retail demand, evidenced by the rapid success of recent additions like Chick-fil-A and Wawa. Daily traffic counts of 8,000-10,000 vehicles on Maynard Street, combined with proximity to major employers (UPMC Williamsport, Penn College) and seasonal tourism tied to the Little League World Series, create a stable and growing customer base ideal for food, beverage, and service-oriented businesses.
